## Pet Agreement

Many pets are welcome at **Seacrest 102** and we want you and your pet(s) to have a wonderful vacation. In order to protect the condo and grounds, abide by Florida laws, and respect the privacy of our neighbors, we do require certain conditions of our renters with pets.

We recommend that you take your pet to the veterinarian for an exam before your trip and obtain a copy of medical and current immunization records. State laws require you to carry these papers with you when you cross state lines, and you will need them if your pet needs veterinary care during your trip.

Your pet should have a flea and tick treatment before you leave home, since fleas and ticks are extremely prevalent in Florida. We also suggest that your pet be groomed and have nails clipped prior to the trip.

Florida law requires that all dogs on the beach be leashed at all times, and that all pet droppings be picked up. Bring your potty bags and be sure to take them to the beach with you.

In consideration of neighbors, we cannot accept dogs that bark. If there are complaints, your pet will have to go to a kennel.

Pets will be considered based on breed, age, and weight. Please complete the information below:

### Pet Conditions

- A maximum of two pets is allowed; a non-refundable pet fee of \$200 is charged for the first pet and \$100 for the second pet; 10% taxes are additional to the pet fees.
- Pets must be at least one year old; no puppies are allowed.
- Cats are not allowed.
- Certain breeds may not be accepted; certain weights may not be accepted.
- Pets must be house broken, flea free, well behaved, and quiet.
- Pets must be dry and sand-free before entering the house.
- Pets are not allowed on furniture or bedding. Bring your pet's bed and use it. If you have a lap pet, bring your own towel or blanket and use it. Do not allow pets on our sheets, towels, blankets, duvet covers, or upholstery.
- You must clean up after your pet in the house, in the yard, and on the beach.
- Dogs must be on a leash at all times on the beach.
- You are responsible for damage, odors, stains, or other problems caused by your pet, including extra cleaning time or expense due to pet hair. **Problems caused by your pet will result in forfeiture of all or part of your deposit.**
